Revised Concession Agreement ("RCA") Term Extension

We received today, 19 June 2025, a letter from the Metropolitan Waterworks and Sewerage System's ("MWSS") informing us that, at its first meeting on 18 June 2025, the Economy and Development Council ("**ED Council**" and formerly the National Economic and Development Authority Board), chaired by President Ferdinand R.

Marcos, Jr., approved the 10-year term extension of the RCA, or until 21 January 2047. This extension is pursuant to Section 5 of Maynilad's legislative franchise, Republic Act No. 11600 ("**Franchise**"), authorizing MWSS to extend the RCA's term up to the term of the Franchise in furtherance of the public's interest for affordable water security.
