<p>The applicant must be a resident citizen of the Philippines and at least 60 years of age. The 5% discount on the basic charge shall apply provided (i) the individual official water meter is registered in the name of the senior citizen residing therein, and (ii) the monthly consumption does not exceed 30m3 of water.</p> <p>Subject to the conditions above, the 5% discount is granted per household regardless of the number of senior citizens residing therein. In case the senior citizen applied for a change of name in order to avail of the discount, said discount may be enjoyed only after the lapse of 12 months from the date of application.</p> <p>To avail of the discount, the senior citizen must submit the following requirements:</p> <ul style="list-style-type: none">• A photocopy of the senior citizen identification card issued by the Office of the Senior Citizens Affairs, but the original must likewise be presented for sighting purposes;• Maynilad statement of account;• Contract of Lease in the name of the senior citizen if he/she is a tenant; and• Notarized Special Power of Attorney executed by the senior citizen in favor of the authorized representative, if applicable, together with a valid ID of the authorized representative.
