Revised IPO Timetable

On 24 September 2025, Maynilad Water Services, Inc. (the "**Corporation**") notified the Securities and Exchange Commission ("**SEC**") and the Philippine Stock Exchange ("**PSE**") of the revised timetable for the Corporation's initial public offering ("**IPO**") of its common shares and the listing thereof on the PSE.

The Corporation now targets a listing date of not later than 7 November 2025 (from the previous target listing date of 31 October 2025). Following the accommodation of cornerstone investors for the IPO, the Corporation is extending the IPO timetable to allow more time for investor education, ensuring that investors gain a deeper understanding of the Corporation and its business model for more informed investment decisions.
