#### Item 4. Resignation, Removal or Election of Registrant's Directors or Officers

Retirement of Chief Operating Officer (COO) and Resulting Changes in Management

In the meeting of the Board of Directors of Maynilad Water Services, Inc. (the "Corporation") held on 26 August 2025, the retirement of Mr. Randolph T. Estrellado, Director and Chief Operating Officer ("COO") of the Corporation, effective 1 September 2025, was announced. Mr. Estrellado also tendered his resignation as a member of the Board of Directors of the Corporation effective 1 September 2025.

In view of Mr. Estrellado's retirement, the Board of Directors appointed Mr. Christopher Jaime T. Lichauco, the current Senior Vice President and Head, Customer Experience & Retail Operations ("CXRO"), as the Corporation's COO effective 1 September 2025. Mr. Rodolfo Baylas, the current North District Head, CXRO, was then appointed to the position vacated by Mr. Lichauco effective as of the same date.
